Who are we?

Why this privacy policy?

This Privacy Policy is the result of our intention to make Clients and Users aware of the general privacy and personal data processing regulations. The data is collected and processed in strict observance and compliance with the Personal Data Protection Law.

Ramalhos respects the best practices in the field of security and personal data protection, having approved a demanding programme for this purpose, capable of safeguarding the protection of the data made available to us by all those who in any way interact with the Company.

In this context, Ramalhos has a Personal Data Protection Officer responsible for the implementation and verification of this Privacy Policy, as well as for the defining of clear rules for personal data processing, ensuring that everyone who entrusts us with their personal data processing are aware of how the Company processes data and what rights they have in this matter.

What is personal data?

When we refer to personal data, we refer to any information, of any nature and regardless of its medium, including sound and image, relating to an identified or identifiable individual.

An identifiable individual is a person who can be identified, directly or indirectly, namely by reference to an identification number or to one or more elements specific to the person's physical, physiological, psychological, economic, cultural or social identity.

Who is responsible for data processing?

The entity responsible for the collection and processing of personal data is Ramalhos, who provides this service and who, in the context, decides which data are collected, the means of data processing and for what purposes the data are used.

What kind of personal data do we collect?

Ramalhos, in the scope of its activity, collects and processes the personal data necessary for the provision of services and/or supply of products, in this context, processing data such as your name, address, date of birth, gender, email address, academic qualifications, tax identification number, among other data. This information may be requested when you log in or fill out contact forms within our websites, either as an employee, job applicant, trainee, trainer, supplier, visitor, partner, among others, or when you receive or send email messages, or for services which require registration or

subscription. All personal information related to all the aforementioned stakeholders and others who use the Ramalhos websites, will be processed in accordance with the General Data Protection Regulation (GDPR).

When and how do we collect your data?

Ramalhos collects your data by phone, in writing or via its website, with your consent. As a rule, personal data is collected when the Customer subscribes to one of our products or services.

Some personal data are mandatory and, in case of lack or insufficiency of such data, Ramalhos will not be able to provide the product or service in question, so the Company will inform Clients of the mandatory nature of the data provision.

If you are not a Ramalhos Client, your data will only be processed if you make it available to the Company, specifically, if you subscribe to the sending of newsletters, in which case, the rules of this Privacy Policy will apply.

The personal data collected are processed by computer, in strict compliance with the legislation on personal data protection. It is stored in specific databases, created for this purpose and, under no circumstances, will the data collected be used for any purpose other than that for which consent was given by the data owner.

How long do we keep your personal data?

The period of time during which data is stored and saved varies according to the purpose for which the information is processed.

Effectively, there are legal requirements which require data to be kept for a minimum period of time. Therefore, and whenever there is no specific legal requirement, data will be stored and saved only for the minimum period necessary for the purposes which led to its collection or its further processing or, for the period of time authorised by the National Data Protection Commission, after which it will be eliminated.

How can you access, rectify or object to the processing of your personal data? Under the terms of the Personal Data Protection Regulation, the data owner is guaranteed the right to access, update, rectify or delete their personal data, which may take place through the various contacts Ramalhos provides.

If you wish, you can cancel your registration or use at any time and you can choose not to receive any email messages, and you can also choose to delete all your personal information from our database.

The data owner also has the right to receive a copy of their personal information in our possession. The company reserves the right to charge a small fee for administrative and IT costs for the carrying out of this request.

If you are a user of our websites through the user registration process, your data will be stored in a specific user control database. However, the Data Owner may request its elimination whenever they wish, by a written request to our official address on the website.

How do we keep your data safe?

- Restricted personal access to your personal data based on the "need to know" criterion and only within the scope of the stated purposes;
- Transfer of collected data only in encrypted form;
- Storage of highly confidential data;

- Protection of information technology systems through firewalls, in order to prevent unauthorised access to your personal data; and
- Permanent monitoring of access to information technology systems with the objective of preventing, detecting and preventing the misuse of your personal data.

How can you object to receiving contacts for marketing purposes?
